Sealed bids for the furnishing of all labor and material necessary for City of Dunkirk Dunkirk Farmer's Market Agrarian Pavilions Construction Project will be received by the City of Dunkirk City Clerk at City Hall, 342 Central Avenue, Dunkirk, New York 14048 until 10:00AM local time May 5<sup>th</sup> 2023. Bid opening will occur the same day at 2:00 PM where bids will be opened publicly and read aloud.

Bids will be received for the following Contract:

Contract No.1- General Construction:

**Bid - Dunkirk Farmer's Market Agrarian Pavilions Construction Project**

Site is an existing parking lot to remain; located at the intersection of Wright Street and Ruggles Street. The address is 45 Cliffstar, Dunkirk, NY 14048 and is owned by City of Dunkirk.

- The approximate area of two open structures is 1,760 square feet.
- The two structures are open except on 10x11 bay in an enclosed shed with 2 leaf 6' wide door.
- The roof is corrugated metal to be selected by owner. Pulin/rafters re 2x6 at 2 feet o.c.
- There are (4) prefabricated cupolas
- The structure is (13) 4x6 frames bolted together that can be pre-assembled or built on site. With (22) 4x6 brace.
- There are (26) concrete piers 12" diameter x 7 feet with rebar.
- Existing asphalt and lawn damage should be patched and repaired.
- SIDEWALK should be bid as add ALTERNATIVE : 1,184 square feet
- Utilities: electric and cold water by owner
- Signs are also by owner
- A building permit is required

A contractor ("Contractor") on any contract resulting from this procurement ("Contract") must document its good faith efforts to provide meaningful participation by MWBEs as subcontractors and suppliers in the performance of the Contract. To that end, by submitting a response to this RFP, the respondent agrees that the Department may withhold payment pursuant to any Contract awarded as a result of this RFP pending receipt of the required MWBE documentation.
